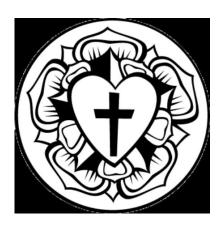

REPORT OF THE SENIOR PASTOR, REV. ANN SCHMID

How very good and pleasant it is when kindred live together in unity. Psalm 133:1

Let me begin on a personal note. Thank you for your outpouring of prayers and support since January 10 when Pastor Broome had his stroke. We have both been upheld and strengthened by your care.

I cannot express how grateful I am that Pastors Kevin, Martha and Kerri have set aside what retired pastors are supposed to do - i.e. leave the congregation - and invited Steve and me to remain as members of Our Redeemer for a time after my retirement. With no family around here, you have been our family for the last 21 years, and we cherish your love and care as we learn what the future holds for Steve.

What a joy and delight it has been to have Pastor Kerri here for most of the last year. She is such a gifted and compassionate pastor. From her work with the preschool to revamping our programming for children and youth after the last couple years, to her work with confirmation kids, and young adults...she has brought so much to Our Redeemer already. And what fun it is to have a pastor who can chant the service well (after 45 years of not having that.)

And, as if having one fine pastor during the transition time after my retirement was not enough, we've been blessed with Pastors Kevin and Martha Clementson being willing to serve as our interim senior pastor. I have known and respected them for almost 40 years, and am thankful to God for bringing them into our congregation.

It has been a blessing to spend more than half my ministry in a healthy congregation, where people can disagree in love, work together without power struggles or threatening to leave if they don't get their own way, and support the ministry with time and money and encouragement for their leaders. That's not always the way it is in Lutheran (or other) congregations, but it is the way of Our Redeemer.

I am grateful to those who have served on church council for the last year. Terry Divelbliss has led us well as president. Our other officers and members, Rolf Otterness, VP; Susan Steffick, Secretary; continuing members Larry Day, Jennifer Hewitt, Sue Lambert, Clint Langley, Becky Long, Martha Rhone, Dan Scher; and retiring members Suzanne Kennedy and Charles Rajakumar have served faithfully and with commitment during this year of transition into a fuller life of worship, service and fellowship. During my years at Our Redeemer I have always looked forward to council meetings because of members' willingness to work together for the good of the church and God's people. Our Treasurer, John Till, and Financial Secretary, Carl Ruppel, continue to serve in their roles in a trustworthy and competent way.

The audit committee and Mission Endowment Fund were very active in 2022 in developing good and helpful policies and protocols. That's work that most people don't see, but which is very important for our ministry.

REPORT OF ASSOCIATE PASTOR, REV. KERRI CLARK

What a joy it is to have experienced almost a whole year of life and ministry with you here at Our Redeemer! It's been wonderful to move through all the activities and seasons of the church year, especially as we've come closer to a "normal" schedule and operations. As the Associate Pastor, half of my work time is dedicated to Children and Youth, which you will see reflected in the following report. Read on for highlights of my ministry over the past year.

Worship – It's been such a treat to share in worship that is creative, well-planned, and rich in musical talent. I loved being able to sing the communion liturgy over the summer with the "Now the Feast and Celebration" liturgy, and am grateful for your openness to learning something new! It was also fun to share with you the "Lessons and Carols Through the Church Year" liturgy for Christ the King Sunday. It was wonderful to be able to display so many of the beautiful banners in the sanctuary and experience together the rhythms of the church year with readings, songs, and art.

Website – One of the first projects I took on was to update the congregation's website. The old website served us well for a time, but it looked dated, was not mobile-friendly, and was complicated to update. Our new website, launched in June, is hosted on Weebly, and allows for easier updates and more pictures.

Noah's Ark Preschool – I love meeting with our preschoolers for chapel each month! We sing songs, read from a story Bible, play together, and pray. I was also able to be present at the Open House this fall, and enjoyed meeting the students' family members.

Youth and Family Ministry

Kids & Families Email – Every Monday afternoon, I send an email to families of our PreK to 6th graders. It gives a brief summary of what we heard in worship and at Growing in God the previous day, offers some questions for family conversation, shares links to seasonal resources, and lists upcoming events. It's been a fun way to share more about what's happening at church, and I hope it's been a helpful resource for families.

Crossroads Confirmation – It's been great to experience class time with our 7th-9th graders as they prepare for Confirmation. In this school year, it's been wonderful to get back into the pattern of having mentors join us for class. Thank you to Jim Mizia, Josh & Jackie Beck, Alex Stitt, and Stacey & Jim Wold for guiding our Crossroads students.

K-6th graders – We started off the year with a time of learning and play during Wednesday evenings in Lent. Once the weather warmed, we started with "Playground Picnics" on Friday evenings - family gatherings with dinner and play time. We moved into the Social Hall for the chilly winter months, but it's been wonderful to have a chance to play together and catch up each month with both kids and parents.

7th-12th graders – My goal was to offer one event per month, and I have intentionally varied the activities and day/times to try to see what draws the most interest. We've tried game nights, service projects, movies, and outings, and will continue to see what seems to work best. Please also let me know about your games, recitals, plays, and other events – I'd love to come and support you at those activities!

Growing in God – I have enjoyed leading music for the 1st-6th graders at the beginning of Growing in God each Sunday. We've learned some new songs, and sung familiar ones, too, often incorporating instruments, hand motions, and lots of movement!

Vacation Bible School – I enjoyed working with the VBS planners and serving as "emcee" for our Opening and Closing each day at VBS. To bring us in line with Child Protection Policies in Pennsylvania, this year we asked all adult helpers to complete volunteer clearances, which are valid for 5 years. This was an extra step, but I so appreciate everyone's willingness to put in the extra work as we remain committed to being a safe place for children and youth.

Looking Ahead

2023 will be a year of transition, grief, and possibility for us as a congregation as we say goodbye to Pastor Schmid after a long tenure here. I am looking forward to working with Pastors Kevin and Martha Clementson, as well as continuing to deepen relationships with each of you. I am eager to explore new ways of connecting with children, youth, and their families, and hope to be a partner and resource for you as we all learn and grow.

Some things that are new for 2023 include:

Youth Group – 7th to 12th graders will gather to cook and eat a meal and share in fellowship on a Sunday afternoon prior to our Crossroads class each month. If anyone would like to teach us a favorite recipe or help us cook, let me know!

Young Adult Fellowship – Young adults (18-25ish) gathered for a meal early in the year while some of our college students were still in town, and we talked about making plans for game nights, more meals, service projects, and other activities together. Look for details in upcoming newsletters and bulletins!

Inclusive Worship and Welcome – During Advent, we had the great delight to learn the American Sign Language (ASL) signs to accompany our singing of "Soon and Very Soon". Encouraged by the response to this, a small group is exploring ways to make our worship more inclusive and welcoming for the Deaf community. We have applied for a grant from the synod's Mission Endowment Fund which would allow us to hire a certified ASL interpreter to be present at one worship service per month for the period of one year, and for an interpreter to consult with us as worship leaders and congregation members about learning the signs for a few key parts of the liturgy. If you'd like to be involved in this project, please be in touch with me, Pastor Kevin, or Jena Oberg.

Thank you for your partnership in this ministry, for welcoming me and Daniel and Wade this year, and for your patience and time and enthusiasm as we journey together!

REPORT OF THE COUNCIL PRESIDENT, TERRY A. DIVELBLISS

2022 was a dynamic year for Our Redeemer. We continued to move towards a new (and improved) normal that has felt more and more familiar and comfortable as the year progressed. The sanctuary contains many people for in-person worship at all three services, and we've resumed many of the annual social activities that are treasured and eagerly anticipated by our congregation.

2022 was an exciting year as we witnessed Vicar Katie become Pastor Katie and we wished her the best as she assumed her first pastoral call. We also welcomed Pastor Kerri to our congregation with her positive energy, enthusiasm, and fresh perspective. She's been a wonderful addition to our church leadership team.

2023 promises to be a year of transition, reflection and opportunity for our congregation. Pastor Schmid will be retiring at the end of January after two decades of tremendous guidance and leadership. We'll miss having her at the pulpit and providing her pastoral care to so many of our families. After that time, Pastors Kevin and Martha Clementson, already members of ORLC, will be combining their time and talents to serve our congregation. This will give us a chance to recalibrate and think about where we are and where or what we would like our congregation and worship experience to be moving forward. Council will be establishing channels for feedback and suggestions throughout the first half of the year. Your feedback will be utilized for planning and when we establish a call committee, which is expected to be by early Fall 2023.

We remain debt-free and are in a very stable financial position thanks to the congregation's continued generosity. There will be some expenses on the horizon as our current facility approaches the quarter-century mark, and council will plan and prepare for us to tackle projects as needed over the next few years with minimal impact.

My personal thanks go out to all of our council members who volunteer their time and provide their thoughtful leadership both as part of council as a whole, but also as members of committees that keep key aspects of our congregation running effectively. Suzanne Kennedy, Rolf Otterness, Charles Rajakumar and Susan Steffick are all departing at the end of their terms. Larry Day, Jennifer Hewitt, Susan Lambert, Clint Langley, Becky Long, Martha Rhone and Dan Scher will each be continuing in 2023.

Thanks to Barb Schumacher for her work as she continued to drive our Audit activities and provide leadership for the Mission Endowment Committee in 2022. Her efforts have positioned us to move forward smoothly in 2023. John Till and Carl Ruppel continue to make it look easy as our Treasurer and Financial Secretary, respectively. Elaine Dolcich, our Office Administrator, orchestrates so much behind the scenes to make us all look like we're experts at what we do. We couldn't do it as well without her. Mary Helen Barr continues to enhance our worship experience each and every week, adapting new approaches to sharing the joy of music during two years of evolving circumstances. Many thanks to each of you.

Most of all, thanks to every congregational member who offers your time and talents to your church family and the communities that we serve in any way – worship assistants, ushers, Sunday school and Vacation Bible School staff, kitchen workers, Wednesday workers, and many others who quietly but definitely make Our Redeemer a special family.

Finally, I ask for you to be involved this year and help our congregation make the most of our opportunity to re-commit to the things we do so well and to determine our direction as we do God's work in the future. Wishing you all many blessings in 2023.

REPORT OF THE OFFICE ADMINISTRATOR, ELAINE DOLCICH

For the past twenty-one years I have been the Office Administrator at Our Redeemer. My responsibilities include, but are not limited to: creating printed bulletins for the Pastor, Associate Pastor, Music Director, camera operator and PowerPoint volunteer as well as the one distributed at worship; creating the PowerPoint presentation on the screen; updates to the parish register, online database, directories, website, and road sign; ministry schedule; communication, including Constant Contact emails; vouchering church expenses (excluding payroll); and ordering office, janitorial and worship supplies. Martha Rhone has relieved me of creating the newsletter. I still handle the mail merging file for those without emails, create a PDF of the newsletter with links that I upload it to our website and send in a Constant Contact email

For the first three years of a child's life, a newsletter (Cradle Roll) is sent to the parents. Our Cradle Roll mailers are Karen Glass, Carol Miller, Paula Reese, and Dianne Rigby. As of January 1, 2023 we are sending monthly mailings to 5 children.

We also have a "Sunshine Lady" in Sue Russo. She sends out get-well, sympathy and new baby cards to members as needed.

As a reminder, members can access our online database. There you can see our directory and family photos. You can also access your own financial contributions. You cannot make any changes. You would need to contact the church office if you see something that needs updated. If you would like access, send an email to the church. You will then receive an email from ICON (our database software provider) with a link to create your login. There is a link to ICON on the homepage of our website.

It has been a pleasure working for you.

AUDIT COMMITTEE

Our Redeemer Lutheran Church's 2021 financial records and supporting files were reviewed by Audit Committee members Gary Milavec (chairman), Dave Borra, and Patti Day. The ELCA publication "Congregational Audit Guide" provided the framework for the review including examining samples of records covering the financial activities of the church. The audit did not include Noah's Ark Preschool financial activity which is audited separately.

The congregation's financial records were found to be in order and materially accurate. The records were neat and well organized. Pastor Schmid (Senior Pastor), Elaine Dolcich (Office Administrator), John Till (Treasurer), Carl Ruppel (Financial Secretary) and Rolf Otterness (Finance Committee member) were generous with their time and were responsive to questions. While the current practices allow the financial activities to run smoothly, there are opportunities to strengthen existing policies and procedures to streamline operational efficiencies and to enhance the internal controls to protect the congregational finances. Recommendations to council included:

- 1. Revise the process for online purchases to exclude a review of the voucher by the Senior Pastor unless an individual purchase is greater than \$500. The majority of purchases are made online with a credit card that has a \$16,500 limit. Currently the Office Administrator makes the purchase, creates the voucher, and receives the delivered good. Having the senior pastor sign off on multiple minor purchases in a month is cumbersome and unnecessary in the Audit Committee's opinion. Furthermore, the Treasurer reviews all vouchers prior to making payment which provides a second set of eyes on all purchases.
- 2. Establish written guidelines for what dollar amount constitutes a major maintenance expenditure and what dollar amount requires council approval. Once an expenditure is approved, the Property Committee should provide an update to council regarding the actual cost versus the approved cost. If the actual cost exceeds the approved cost, the Property Committee member in charge of the particular project should sign off on the vendor invoice prior to payment.
- 3. Include signed internet and computer usage forms for all employees, including those of Noah's Ark, in the personnel files.
- 4. Purchase Norton Small Business for Nonprofit (\$30/year for 10 devices). The church is currently relying on Windows Defender and would benefit from a product such as Norton.
- 5. Verify/apply Windows updates to all PCs and laptops.
- 6. Verify who has access to all public computer folders in order to restrict unauthorized access.
- 7. Update organizational procedures developed by the Treasurer, Financial Secretary, and Office Administrator to ensure they can be understood and applied by users other than the authors.
- 8. Consider succession planning. Given the complexity and volume of work performed by our Treasurer, Financial Secretary, and Office Administrator the Audit Committee believes it is prudent to not only properly document their procedures but to also train others to step into their roles if needed so that the church can continue to function on a daily basis.

As noted on previous audits, the following areas still present opportunities to improve:

- 1. Develop a records retention policy and plan for implementation. The plan should include how to properly and securely store information containing personal and confidential information such as payroll records and W-2s. The audit committee intends on submitting a draft of this policy for council's review within the next several months.
- 3. Develop a fixed asset policy and procedures.

Enhancements made after the 2020 audit or during the 2021 audit included:

- 1. Registered Our Redeemer Lutheran Church as a fictitious name with the state of Pennsylvania so we can now legally do business as (DBA) Our Redeemer Lutheran Church in addition to The Evangelical Lutheran Church of Our Redeemer of Peters Township (our legal name).
- 3. PC Audit, a free software program, was run on all PCs and laptops owned by the church. Summary spreadsheets were created detailing all software and hardware contained on each machine. This process should be repeated at least annually and any unused programs should be removed.
- 4. Cyber Suite (\$100,000 limit) and Computer Fraud (\$25,000 limit) coverages were added to our insurance policy.
- 5. Upon the Treasurer's request Washington Financial changed all bank account statement reporting periods to be on a calendar month basis, which will simplify and clarify monthly bank reconciliations.
- 6. The Office Administrator established a shared drive folder titled "Policies/Procedures."

The auditors performed many of the procedures and testing as outlined in the Congregational Audit Guide. In doing so, the auditors reviewed the procedures governing the financial reporting and operations process and found the balances presented to be materially correct, procedures proper, and records properly kept except as noted above.

The audit report was approved by council and a summary of the audit results was forwarded to the Synod office as required.

CHILDREN AND YOUTH MINISTRY

CHRISTIAN EDUCATION

Growing in God classes for age 3 through grade 6 were in-person this year, although the attendance has been lower than in the past. This fall the Adult Discussion Group met with Pastor Schmid for Bible study during the regular Sunday School hour (10-10:45 AM). Attendance is lower than in the past, since the most that have attended the Bible study this fall was 11.

The theme for Vacation Bible School this year was "Makes Waves: What You Do Today Can Change the World Around You." VBS was held July 25-28 for 84 children and youth from age 3 years through grade 6.

The attendance this fall was greater than in the spring term except for the grade 4-6 class, which decreased from as many as 9 down to 4 students.

Some of that decrease is from the change of grades with the youth who moved from grade 6 to grade 7. The other classes showed a marked increase in participation. The regular classes are now using the Spark House Lectionary curriculum. The classes that featured group activities were the following: (1.) **Luther Fest,** which was intergenerational for the first time this year, received good reviews from many; (2.) **Advent Adventures.**

Breakfast at the Manger resumed since 2019 with over 120 attendees. Lori Greene was the director of this event and the storyteller. The theme this year was "The Spider's Gift." The Fellowship Committee oversaw the breakfast, which was mostly breakfast breads donated by those attending.

The mission project with Blessings in a Backpack was continued this year. The MEF committee will meet in the first quarter of 2023 to determine distribution of the 2022 fund income. There were no donations in 2022 so only the fund income of \$3,160 will be distributed.

The committee decided the best investment opportunity for the proceeds of the certificate of deposit that matured in December 2021 was to consolidate all MEF monies into the ELCA Ministry Growth Fund. \$21,440.41 was transferred to the Ministry Growth Fund in 2022.

The committee and Rolf Otterness spent many hours thoughtfully reviewing the committee bylaws and making recommendations to bring the bylaws in line with current practice and Synod endowment fund bylaws.

Proposed bylaw changes that are substantive include:

- 1. changing "committee" to "Board" and removing:
 - The Congregation Council shall be responsible for overseeing the work of the Mission Endowment Fund.
 - All MEF Committee recommendations must be approved by the Congregation Council.
- 2. changing "immediately" to "during the first quarter of the following year" for distributing 10% of each gift.
- 3. changing the accounting of the MEF funds from "separate, distinct and independent" to "distinct and easily identifiable".
- 4. adding verbiage for permitting remote communications including electronically and by telephone or video conference.
- 5. adding modifier "up to" to the three percent (3%) additional distribution if MEF assets exceed \$250,000.
- 6. adding "and any of its congregations, agencies or institutions" to Southwestern Pennsylvania Synod of the ELCA.

The committee thanks Jeanne Zoellner for her service on the committee. The committee also thanks Rolf Otterness and John Till for their assistance to the committee. It has been my pleasure to serve on the MEF Committee for four years. I am confident that the committee is in good hands!

PROPERTY COMMITTEE

2022 was another busy year for the property committee with no shortage of smaller maintenance projects, as our "new" building approaches 24 years old.

A few of the more significant projects to be completed included the installation of railings along the social hall exit steps, a repair to the collapsed pavement around the storm drain in the lower front corner of the parking lot, electrical outlet repairs and upgrades around the pavilion and pit, HVAC maintenance, and repairs to wastewater lines that shifted during excavation work across Gateshead Drive. (This latter repair was completed at no charge to ORLC by Peters Township and the contractor that damaged the lines.) Also, a significant debris cleanup was completed in the woods behind the utility shed. Since Grass Masters is now maintaining the lawn, we were able to sell our tractor and push mower. Some hand tools and trimmers were retained for odd projects and touch ups.

Keith Lowery, John Till, and Gary Milavec tackled any number of random repair issues that popped up, as did Shawn Moody. Keith and John anchored several of the major projects, coordinating with contractors and the township as needed. Larry Day weighed in on discussions and decisions as a property committee member. Many thanks to each of them for their efforts.

As with any aging facility and surrounding property, we are facing two larger and more costly projects in the coming years. First, the parking lot will require repairs and eventually a complete repave. We have a bid for repairs to a few large areas to extend the life of the parking lot, and we also have initial estimates for a complete repave. The committee and council are evaluating the best option and use of our funds.

Also, Peters Township asked us to voluntarily have a camera test of the stormwater drainpipes that run parallel to Route 19. We did so in late Fall, and there are some failing areas and issues. We don't expect any imminent failures such as the one that our neighbors next door (the NAPA/gym/Seafood Kitchen plaza) experienced, but we do need to start planning how to fund a repair that will eventually be necessary and expensive. This will be a council conversation in early 2023 as well.

Two other key projects on the near-term radar include a major upgrade to our sanctuary sound system to provide a better in-person and livestreamed worship experience, and the addition of numerous electrical outlets to the social hall for improved convenience and safety.

Overall, thanks to a dedicated team of volunteers and the oversight of Property Committee members, our facility should continue to serve us well for many years to come.

SERVICE/OUTREACH COMMITTEE

We collected goodies and sent 20 college care packages in time for the February 13, 2022 Super Bowl.

We now have a City Mission Clothing/Shoe Bin. The bin is located right beside the paper recycle bins in our parking lot.

Through Lutheran Disaster Response, we collected donations that went to Ukraine through the "Eastern Europe Crisis Response". It provide refugees with immediate support and supplies such as food, blankets, water and hygiene kits.

We had a Summer Series in July. July 17 – Shelley Kubincanek, the Church/Community Relations Manager from the City Mission, joined us to tell us what they are doing and bring us up to date. July 31-Our church family member, Soheila Lunney, who is originally from Iran shared her story with us.

On August 23, Pastor Kerri and members of our church toured City Mission.

We are now collecting and delivering monthly to the City Mission Food Pantry. Special items for each month are listed in the bulletin, newsletter and Constant Contact. This past Thanksgiving we collected and provided items needed to pack the Boxes of Love which provided a meal for the families.

ELCA Day of Service – We were able to provide 72 school kits and numerous fabric kits which went to Lutheran World Relief. Barb Schumacher delivered them to the drop-off location in Zelienople.

SERRV – Members were encourage to go online to purchase gifts for Christmas at www.serrv.org.

ELCA Good Gifts - These were also purchased through the church. \$830 was donated and submitted during a matching gifts period.

Christmas card collection: We collected the fronts of used Christmas cards. They are used as tags to accompany 20,000 hygiene kits distributed to the poor in the Appalachian region of West Virginia, Kentucky, Virginia and southern Ohio.

We collected Christmas gifts for the children served by the Washington County Children and Youth Services. Again this year we did not have tags, just collected donations. Elaine Dolcich organized, and Kristie Chestney delivered the Christmas gifts to the Washington County Fairgrounds.

 - 1) Up to 40% for special projects within the local area wherein the Congregation resides;
 - 2) Up to 40% for special ministries of the Southwestern Pennsylvania Synod of the ELCA and any of its congregations, agencies or institutions;
 - 3) Up to 40% for ELCA Church-wide ministries;
 - 4) Up to 20% for extraordinary programs/ministry initiatives within this Congregation;
 - 5) If the amount to be distributed is less than \$1,000, the whole amount may be allocated to one or more of the above categories without regard to the above percentage (%) limitations for each category.
 - b. To determine how the MEF assets will be invested, including the asset allocation. The investment objective will be to provide long-term growth so the annual distribution will keep pace with inflation, i.e. the annual distribution will maintain its purchasing power. In any event, all investments shall be invested by outside investors such as in the ELCA Ministry Growth Fund and/or the ELCA Mission Investment Fund. No Board member shall invest the assets in a way that would bring private inurement to that individual.
 - c. To begin making annual distributions of income once the MEF assets reach \$50,000 in value on the previous year end valuation date. Income for distribution is defined as interest, dividends and realized gains. Income for the previous year shall be distributed during the first quarter of the next year. If the MEF assets exceed \$250,000 in value on the year end valuation date, the next year's distribution may include up to a three percent (3%) distribution of that year end value in addition to the annual distribution. The Board shall keep in mind that the MEF is intended to be a perpetual fund.
 - d. To encourage gifts to the MEF through education and promotion of the fund. The Board may use the services of the ELCA Foundation Regional Gift Planner in assisting members with the best way to include the MEF in their current giving and estate plans.
 - e. To receive and celebrate gifts given for ministry through the MEF and maintain a permanent book of remembrance of donors to the MEF.

In the event ORLC ceases to exist, either through merger or dissolution, disposition or transfer of the MEF shall be at the discretion of the Congregation Council in conformity with Chapter 7 of the approved Congregational Constitution and in consultation with the Bishop of the Southwestern PA Synod.
